## ROAD FUEL SURCHARGE

### Road - UK & International surcharge

The standard road surcharge applies to all Carousel shipments and is based on the last week of the month weighted average fuel consumer prices of diesel fuel for CE/EC/EG Euro Area 19, inclusive of duties and taxes from two months prior. Weekly updates are published by the European Commission Directorate General for Energy and Transport in the Oil Bulletin.

The following table illustrates the surcharge for road services:

## AIR FUEL SURCHARGE

### Air - UK & International surcharge

Carousel uses an index-based surcharge that is adjusted monthly. Changes to the surcharge will be effective the first day of each month. The surcharge will be based on the U.S. Gulf Coast (USGC) prices for kerosene-type jet fuel as reported by the U.S. Energy Information Administration (EIA) for the month that is two months prior to the adjustment.

The following table illustrates the surcharge for air services:
